Statement of intent

At our school we provide a rich and varied learning environment that allows all children to develop their knowledge, skills and abilities to their full potential through being informed, articulate and empowered learners. In RHE, this means children are given the tools with which to build lasting and meaningful relationships for life, to stay safe and also to make good decisions about their health and wellbeing. Through our PSHE and RHE curriculum, we strive to help our pupils develop into happy, confident, well-rounded members of society, who can make a positive contribution to their community.

We intend for the principles and positive messages covered within RHE to be integrated into whole school life and the ethos of the school. Children's attitudes towards themselves, towards their learning and towards others are positively strengthened through the knowledge and skills developed through our RHE curriculum.

1. Legal framework

- 1.2. This policy operates in conjunction with the following school policies:

 - Good Behaviour Policy
 - SEND Policy
 - Anti-Bullying and Anti-harassment Policy
 - E-safety Policy
 - LGBTQ+ Policy
 - PSHE Policy

2. Roles and responsibilities

- 2.1. The governing body is responsible for:
 - Ensuring all pupils make progress in achieving the expected educational outcomes.
 - Ensuring the curriculum is well led, effectively managed and well planned.
 - Evaluating the quality of provision through regular and effective selfevaluation.
 - Ensuring teaching is delivered in ways that are accessible to all pupils with SEND.
 - Providing clear information for parents on subject content and their rights to request that their children are withdrawn.
 - Making sure the subjects are resourced, staffed and timetabled in a way that ensures the school can fulfil its legal obligations.
 - Ensuring the religious ethos of the school is maintained and developed through the subjects.
- 2.2. The headteacher is responsible for:
 - The overall implementation of this policy.
 - Ensuring staff are suitably trained to deliver the subjects.
 - Ensuring that parents are fully informed of this policy.
 - Reviewing requests from parents to withdraw their children from the subjects.
 - Discussing requests for withdrawal with parents.

- Organising alternative education for pupils, where necessary, that is appropriate and purposeful.
- Reporting to the governing board on the effectiveness of this policy.
- Reviewing this policy on a 2 year basis.

2.3. The relationships and health education subject leader is responsible for:

- Overseeing the delivery of the subjects.
- Ensuring the subjects are age-appropriate and high-quality.
- Ensuring teachers are provided with adequate resources to support teaching of the subjects.
- Ensuring the school meets its statutory requirements in relation to the relationships and health curriculum.
- Ensuring the relationships and health curriculum is inclusive and accessible for all pupils.
- Ensuring the inclusion of LGBTQ+ within the curriculum
- Working with other subject leaders to ensure the relationships and health curriculum complements, but does not duplicate, the content covered in the national curriculum.
- Monitoring and evaluating the effectiveness of the subjects and providing reports to the headteacher.

2.4. The teachers are responsible for:

- Delivering a high-quality and age-appropriate relationships and health curriculum in line with statutory requirements.
- Using a variety of teaching methods and resources to provide an engaging curriculum that meets the needs of all pupils.
- Ensuring they do not express personal views or beliefs when delivering the programme.
- Modelling positive attitudes to relationships and health education.
- Ensuring the inclusion of LGBTQ+ within their curriculum
- Responding to any safeguarding concerns in line with the Child Protection and Safeguarding Policy.
- Acting in accordance with planning, monitoring and assessment requirements for the subjects.
- Liaising with the SENCO to identify and respond to individual needs of pupils with SEND.
- Working with the relationships and health education subject leader to evaluate the quality of provision.

2.5. The SENCO is responsible for:

- Advising teaching staff how best to identify and support pupils' individual needs.
- Advising staff on the use of TAs in order to meet pupils' individual needs.

3. Organisation of the curriculum

- 3.1. Every primary school is required to deliver statutory relationships education and health education.
- 3.2. For the purpose of this policy, "relationships and sex education" is defined as teaching pupils about healthy, respectful relationships, focussing on family and friendships, in all contexts, including online.
- 3.3. For the purpose of this policy, "health education" is defined as teaching pupils about physical health and mental wellbeing, focusing on recognising the link between the two and being able to make healthy lifestyle choices.
- 3.4. The delivery of the relationships education and health education will be delivered as part of the school's PSHE curriculum.
- 3.5. The relationships and health curriculum has been organised in line with the statutory requirements outlined in the DfE (2019) 'Relationships Education, Relationships and Sex Education (RSE) and Health Education' guidance.
- 3.6. The relationships and health curriculum takes into account the views of teachers, pupils and parents. We are dedicated to ensuring our curriculum meets the needs of the whole-school community. We have a LGBTQ+ inclusive curriculum.
- 3.7. The relationships and health curriculum is informed by issues at Overleigh and in the wider community to ensure it is tailored to pupils' needs.
- 3.8. We consult with parents, pupils and staff in the following ways:
 - Questionnaires and surveys
 - Meetings
 - Newsletters and letters
- 3.9. Any parent, teacher or pupil wishing to provide feedback about the curriculum can do so at any time during the academic year by:
 - Organising a meeting with the headteacher.
 - Emailing admin@overleighstmarysce.cheshire.sch.uk
 - Submitting written feedback into the suggestions box in the school office.
- 3.10. At Overleigh, we have organised a curriculum that is age-appropriate for pupils within each year group, based on the views of teachers, parents and pupils.
- 3.11. When organising the curriculum, the religious backgrounds of all pupils have been considered, so that the topics that are covered are taught appropriately.

4. Consultation with parents

- 4.1. We understand the important role parents play in enhancing their children's understanding of relationships, sex and health. Similarly, we also understand how important parents' views are in shaping the curriculum.
- 4.2. We work closely with parents by establishing open communication all parents are consulted in the development and delivery of the curriculum, as outlined in section 3 of this policy.
- 4.3. Parents can be provided with the following information:
 - The content of the relationships, sex and health curriculum
 - The delivery of the relationships, sex and health curriculum, including what is taught in each year group
 - The legalities surrounding withdrawing their child from the subjects
 - The resources that will be used to support the curriculum
- 4.4. We build positive relationships with parents by inviting them into school to discuss what will be taught, address any concerns and help parents in managing conversations with their children on the issues covered by the curriculum.
- 4.5. Parents are consulted in the review of the curriculum and this policy, and are encouraged to provide their views.

6. Relationships education per year group

- 6.1. We have decided, within the statutory curriculum content outlined in section 5, what pupils are taught during each year group.
- 6.2. We considered the age and development of pupils when deciding what will be taught in each year group.
- 6.3. We plan a progressive curriculum, such that topics are built upon prior knowledge taught in previous years as they progress through school to provide a smooth transition to secondary school.
- 6.4. The content formally taught in each year group is based on the coverage within the PSHE scheme, HeartSmart, as listed below. However, further content will be covered again at other times, for example on themed days and weeks or through Act of Worship or other subject content, including shared books.

7. Health education overview

7.1. The focus at primary level is teaching the characteristics of good physical health and mental wellbeing.

Mental wellbeing

- 7.2. By the end of primary school pupils will know:
 - That mental wellbeing is a normal part of daily life, in the same way as physical health.
 - That there is a normal range of emotions, e.g. happiness, sadness, anger, fear, surprise and nervousness.
 - The scale of emotions that humans experience in response to different experiences and situations.
 - How to recognise and talk about their emotions, including having a varied vocabulary of words to use when talking about their own and others' feelings.
 - How to judge whether what they are feeling and how they are behaving is appropriate and proportionate.
 - The benefits of physical exercise, time outdoors, community participation, and voluntary and service-based activity on mental wellbeing and happiness.
 - Simple self-care techniques, including the importance of rest, time spent with friends and family, and the benefits of hobbies and interests.
 - How isolation and loneliness can affect children and that it is very important they discuss their feelings with an adult and seek support.
 - That bullying (including cyberbullying) has a negative and often lasting impact on mental wellbeing.
 - Where and how to seek support (including recognising the triggers for seeking support), extending to who in school they should speak to if they are worried about themselves or others.
 - That it is common to experience mental ill health and, for the many people who do, the problems can be resolved if the right support is made available, especially if accessed early enough.

Internet safety and harms

- 7.3. By the end of primary school, pupils will know:
 - That for most people, the internet is an integral part of life and has many benefits.
 - About the benefits of rationing time spent online.

- The risks of excessive time spent on electronic devices.
- The impact of positive and negative content online on their own and others' mental and physical wellbeing.
- How to consider the effect of their online actions on others.
- How to recognise and display respectful behaviour online.
- The importance of keeping personal information private.
- Why social media, some computer games and online gaming, for example, are age-restricted.
- That the internet can also be a negative place where online abuse, trolling, bullying and harassment can take place, which can have a negative impact on mental health.
- How to be a discerning consumer of information online, including understanding that information (inclusive of that from search engines) is ranked, selected and targeted.
- Where and how to report concerns and get support with issues online.

8. Health education per year group

- 8.1. We have decided, within the statutory curriculum content outlined in section 7, what pupils are taught during each year group.
- 8.2. We considered the age and development of pupils when deciding what will be taught in each year group.
- 8.3. We plan a progressive curriculum, such that topics are built upon prior knowledge taught in previous years as they progress through school to provide a smooth transition to secondary school.
- 8.4. As with Relationships Education above, the content formally taught in each year group is based on the coverage within the PSHE scheme, HeartSmart, as listed below. However, further content will be covered again at other times, for example on themed days and weeks or through Act of Worship or other subject content, particularly Science and P.E.

9. Sex education

- 9.1. All pupils must be taught the aspects of sex education outlined in the primary science curriculum this includes teaching about the main external parts of the human body, how it changes as it grows from birth to old age, including puberty, and the reproductive process in some plants and animals.
- 9.2. All schools are free to determine whether pupils should be taught sex education beyond what is required of the national curriculum.
- 9.3. At Overleigh, we do teach pupils sex education beyond what is required of the science curriculum.

- 9.4. Parents are consulted in the organisation and delivery of our sex education curriculum, in accordance with section 3 and section 4 of this policy.
- 9.5. Parents are given the opportunity to comment on what is taught through sex education.
- 9.6. The age and development of pupils is always considered when delivering sex education.

10. Delivery of the curriculum

- 10.1. The relationships, sex and health curriculum will be delivered as part of our PSHE curriculum.
- 10.2. Through effective organisation and delivery of the subject, we will ensure that:
 - Core knowledge is sectioned into units of manageable size.
 - The required content is communicated to pupils clearly, in a carefully sequenced way, within a planned scheme of work.
 - Teaching includes sufficient and well-chosen opportunities and contexts for pupils to embed new knowledge so that it can be used confidently in real-life situations.
- 10.3. The curriculum is delivered proactively, such that it addresses issues in a timely way in line with current evidence on children's physical and emotional development.
- 10.4. Teaching of the curriculum reflects requirements set out in law, particularly the Equality Act 2010, so that pupils understand what the law does and does not allow, and the wider legal implications of the decisions they make.
- 10.5. At the point we consider it appropriate to teach pupils about LGBTQ+, we ensure that this content is fully integrated into the relationships, sex and health curriculum, rather than delivered as a standalone unit or lesson.
- 10.6. We ensure that all teaching and materials are appropriate for the ages of the pupils, their religious backgrounds, their developmental stages and any additional needs, such as SEND.
- 10.7. Lesson plans provide appropriate challenge for pupils and are differentiated for pupils' needs.
- 10.8. Lessons are usually taught as a class, but lessons may be taught in gender-segregated groups, dependent upon the nature of the topic being delivered at the time, for example additional menstruation lessons in upper KS2.
- 10.9. Throughout every year group, appropriate diagrams, videos, books, games, discussion and practical activities will be used to assist learning.
- 10.10. Resources will be selected with sensitivity given to the age, developmental stage and cultural background of pupils.

- 10.11. Pupils will be prevented from accessing inappropriate materials on the internet when using such to assist with their learning. The prevention measures taken to ensure this are outlined in the school's E-safety Policy.
- 10.12. Teachers will establish what is appropriate for one-to-one and whole-class settings, and alter their teaching of the programme accordingly.
- 10.13. Teachers will ensure that pupils' views are listened to and will encourage them to ask questions and engage in discussion. Teachers will answer questions sensitively, honestly and appropriate to the pupil's age.
- 10.14. The programme will be designed to focus on both boys and girls, and activities will be planned to ensure both are actively involved, matching their different learning styles and needs.
- 10.15. Teachers will discuss the importance of healthy relationships, including marriage, though sensitivity will always be given as to not stigmatise pupils based on their home circumstances.
- 10.16. Teachers will ensure that lessons encourage openness through discussion activities and group work.
- 10.17. Teachers will ensure lessons focus on challenging perceived views of pupils based on protected characteristics, through exploration of, and developing mutual respect for, those different to themselves.
- 10.18. Any resources or materials used to support learning will be assessed by the relationships, sex and health education subject leader before use to ensure they are appropriate for the age and maturity of pupils, and sensitive to their needs.
- 10.19. In teaching the curriculum, teachers will be aware that pupils may raise topics such as self-harm and suicide. These will be dealt with sensitively and in an age-appropriate way.
- 10.20. At all points of delivery of this programme, parents will be consulted, and their views will be valued.
- 10.21. Whilst there are no formal examinations for the relationships, sex and health curriculum, we will undertake informal assessments to determine pupil progress these will include verbal and written assignments and presentations, group tasks and projects.

11. Working with external experts

- 11.1. External experts may be invited to assist from time-to-time with the delivery of the programme and will be expected to comply with the provisions of this policy.
- 11.2. We will ensure all visitor credentials are checked before they are able to participate in delivery of the curriculum.
- 11.3. We will ensure that the teaching delivered by the external expert fits with the planned curriculum and this policy.

- 11.4. Before delivering the session, we will discuss the details of the expert's lesson and ensure that the content is age-appropriate and accessible for the pupils.
- 11.5. We will also ask to see the materials the expert intends to use, as well as a copy of the lesson plan, to ensure it meets all pupils' needs, including those with SEND.
- 11.6. We will agree with the expert the procedures for confidentiality, ensuring that the expert understands how safeguarding reports should be dealt with in line with the Child Protection and Safeguarding Policy.
- 11.7. The intended use of external experts is to enhance the curriculum delivered by teachers, rather than as a replacement for teachers.

12. Equality and accessibility

- 12.1. The school understands its responsibilities in relation to the Equality Act 2010, specifically that it must not unlawfully discriminate against any pupil because of their:
 - Age
 - Sex or sexual orientation
 - Race
 - Disability
 - Religion or belief
- 12.2. We are committed to making reasonable adjustments wherever possible to promote accessibility and inclusivity of the curriculum.
- 12.3. We understand that pupils with SEND or other needs (such as those with social, emotional or mental health needs) are entitled to learn about relationships, sex and health education, and the programme will be designed to be inclusive of all pupils.
- 12.4. Teachers will understand that they may need to be more explicit and adapt their planning of work and teaching methods in order to appropriately deliver the programme to pupils with SEND or other needs.
- 12.5. Provisions under the Equality Act 2010 allow our school to take positive action, where it can be evidenced to be proportionate, to respond to particular disadvantages affecting a group because of a protected characteristic.
- 12.6. When deciding whether support is necessary to support pupils with a particular protected characteristic, we will consider our pupils' needs, including the gender and age range of our pupils.
- 12.7. In order to foster healthy and respectful peer-to-peer communication and behaviour between boys and girls, the school implements a robust Good Behaviour Policy, as well as a Child Protection and Safeguarding Policy, which set out expectations of pupils.

12.8. The curriculum at Overleigh fully integrates LGBTQ+. More detail can be found in the LGBTQ+ Policy.

13. Curriculum links

- 13.1. We seek opportunities to draw links between relationships, sex and health education and other curriculum subjects wherever possible to enhance pupils' learning.
- 13.2. Relationships, sex and health education will be linked to the following subjects in particular:
 - **Science** pupils learn about the main external parts of the body and changes to the body as it grows from birth to old age, including puberty.
 - Computing and ICT pupils learn about e-safety, including how to use technology safely, responsibly, respectfully and securely, how to keep personal information private and how to access help and support.
 - PE pupils explore various physical activities, are physically active for sustained periods of time, engage in competitive sport and understand how exercise can lead to healthier lifestyles.
 - **Citizenship** pupils learn about the requirements of the law, their responsibilities and the possible consequences of their actions.
 - **PSHE** pupils learn about respect and difference, values and characteristics of individuals.

14. Withdrawing from the subjects

- 14.1. Relationships and health education are statutory at primary and parents **do not** have the right to withdraw their child from the subjects.
- 14.2. As sex education is not statutory at primary level (other than what must be taught as part of the science curriculum), parents have the right to request to withdraw their child from all, or part of, the sex education curriculum.
- 14.3. The headteacher will automatically grant withdrawal requests in accordance with point 14.2; however, the headteacher will discuss the request with the parent and, if appropriate, their child, to ensure that their wishes are understood and to clarify the nature and purpose of the curriculum.
- 14.4. The headteacher will discuss with the parent the benefits of receiving this important education and any adverse effects that withdrawal may have on the pupil this could include, for example, social and emotional effects of being excluded.
- 14.5. The headteacher will keep a record of the discussion between themselves, the pupil and the parent.
- 14.6. The headteacher will grant a parent's request to withdraw their child from sex education, other than the content that must be taught as part of the science curriculum.
- 14.7. The parent will be informed, in writing, of the headteacher's decision.

14.8. Where a pupil is withdrawn from sex education, the headteacher will ensure that the pupil receives appropriate alternative education.

15. Behaviour

- 15.1. The school has a zero-tolerance approach to bullying. We foster a culture based on mutual respect and understanding for one another.
- 15.2. Any bullying incidents caused as a result of the relationships, sex and health education programme, such as those relating to LBGQT+, will be dealt with and recorded on CPoms.
- 15.3. Any occurrence of these incidents will be reported to a member of school staff, who will then discipline the pupil once they are on school premises.
- 15.4. These incidents will be dealt with following the processes in our Good Behaviour Policy, Anti-Bullying and LGBTQ+ Policy.

16. Staff training

- 16.1. All staff members at the school will undergo catch up training regularly to ensure they are up-to-date with the relationship, sex and health education programme and associated issues.
- 16.2. Members of staff responsible for teaching the subjects will undergo further training when necessary, led by the relationships, sex and health education subject leader, to ensure they are fully equipped to teach the subjects effectively.
- 16.3. Training of staff will also be scheduled around any updated guidance on the programme and any new developments (such as 'sexting') which may need to be addressed in relation to the programme.

17. Confidentiality

- 17.1. Confidentiality within the classroom is an important component of relationships, sex and health education, and teachers are expected to respect the confidentiality of their pupils as far as is possible.
- 17.2. Teachers will, however, alert the headteacher about any suspicions of inappropriate behaviour or potential abuse as per the school's Child Protection and Safeguarding Policy.
- 17.3. Pupils will be fully informed of the school's responsibilities in terms of confidentiality and will be aware of what action may be taken if they choose to report a concern or make a disclosure.
- 17.4. Any reports made during lessons, or as a result of the content taught through the curriculum, will be reported and handled in accordance with the Child Protection and Safeguarding Policy.

18. Monitoring quality

- 18.1. The relationships and health education subject leader is responsible for monitoring the quality of teaching and learning for the subjects.
- 18.2. The relationships and health education subject leader will conduct subject assessments on a termly basis, which will include a mixture of the following:
 - Self-evaluations
 - Lesson observations
 - Learning walks
 - Planning and Work scrutiny
- 18.3. The relationships and health education subject leader will create annual subject reports for the headteacher and governing board to report on the quality of the subjects.
- 18.4. The relationships and health education subject leader will work regularly with the headteacher and RSE link governor to evaluate the effectiveness of the subjects and implement any changes.
